Chosen project and

The project chosen by our team on the "Open Coesione" platform is "TRASPORTI E MOBILITA".

Out of all the other options, we decided to choose this one because we believe it is important to protect the society and that's exactly the purpose of cycle paths. Those roads protect cyclists from traffic, and here's how cycle paths separate bicycle traffic from motorized and pedestrian traffic, which have different speeds, this action improves road safety and facilitates the flow of vehicles. Precisely because of the greater safety of cyclists, they also play the role of a tool for shifting mobility quotas from private motorized vehicles to bicycles, reducing congestion and pollution. Our aim is to increase sustainable mobility, make the air that we breathe way cleaner and improve everyone's quality life by doing so.

Brief description of your civic monitioning research

Our research has revealed concerns and controversy about Marsala's bike path, particularly in the Capo Boeo area. The municipality ensures close monitoring of the implementation, with a variant to ensure safety. The work which resumed after a hiatus, involves the creation of promiscuous sections and the introduction of signage. The situation raises questions about safety, especially regarding the passage of heavy vehicles and the narrowness of the roadway. The description of the situation during the site visit highlights potential challenges for pehicles and cyclists. The cipic monitoring research aims to understand and address these issues. especially at curves such as Capo Boeo, to ensure safety when the track is operational. KF.Y-WORDS:

Contextual informations

The project from www.opencoesione.gov.it is part of the 2014/2020 plan. European funds haven't been used yet. The total cost is 2 million, with 1.6 million from the EU and 400,000 from other public sources. The project was supposed to start on 31/07/2023 and end on 31/10/2023, but actual start and end dates are unavailable. The project is ongoing.
